GOALS	REQUIREMENTS
Build and Maintain a Secure Network	<ul style="list-style-type: none">• Install and maintain a firewall configuration to protect cardholder data• Do not use vendor-supplied defaults for your retail point of sale system passwords
Protect Cardholder Data	<ul style="list-style-type: none">• Protect cardholder data stored in your retail point of sale system• Encrypt transmission of cardholder data across open, public networks
Maintain a Vulnerability Management Program	<ul style="list-style-type: none">• Use and regularly update anti-virus software on all machines in your network• Develop and maintain secure systems and applications
Implement Strong Access Control Measures	<ul style="list-style-type: none">• Restrict access to cardholder data in your Retail Pro system to "need-to-know" groups only• Assign a unique ID to each staff member with access to the retail software• Restrict physical access to cardholder data
Regularly Monitor and Test Networks	<ul style="list-style-type: none">• Track and monitor all access to network resources and cardholder data in your POS system• Regularly test security systems and processes
Maintain an Information Security Policy	<ul style="list-style-type: none">• Maintain a policy that addresses information security for all personnel
